HAULING TENDER #3

WARDS 3 & 4 – Ward 3: everything east of Alonsa and from Rd 126N to and including Rd 120N & Ward 4: everything west and south of Alonsa excluding the Harcus area

The Rural Municipality of Alonsa is now accepting tenders for the loading, hauling, and spreading of crushed gravel on the RM of Alonsa roadways.

Please note that quantities are subject to change. A map showing rate of application and location will be provided at a later date.

1. SPECIFICATIONS

- a) Gravel will be supplied from the RM of Alonsa gravel pits at the following location:
 - **SW 19-21-13 WPM** (50°49'03.6"N 99°16'09.6"W)
 - **Road 123N – 3 miles north of PTH 50** (Access from the west side through the Municipality of McCreary)
 - **Within the McCreary Community Pasture** (gate watcher required while hauling)
- b) The successful bidder must supply all supervision, signage – truck turning signs & construction signs, labor materials, equipment, tools, and all other things necessary for the complete supply of the work as indicated by the specifications listed above.
- c) The gravel program shall be completed no later than August 30, 2026. A specific timeframe will be set out in the contract upon award of bid and shall be agreed upon between the contractor and the administrator. Council may grant extension upon written request.
- d) Order of gravel application will be determined and directed by each councilor prior to the start date of program. Daily communication with the councilor will be required to ensure efficiency of the program. The gravel will be spread at a rate of 120 yds/ mile,
- e) The contractor will give 48 hours' notice of commencement of hauling to administrator. The RM needs to prepare the surface.
- f) Hauler must adhere to the maximum weight restrictions of the road.
- g) The successful bidder will be required to submit daily log, submitted on Mondays on a weekly basis, specifying the location that it was hauled to and the yard amounts.
- h) Any road damage caused by the contractor will be the responsibility of the contractor to fix.

2. TENDER SUBMISSIONS

All tender submissions must include the following:

- a) Quotes must be shown as **total price per yard** with all applicable fees clearly stated.
- b) Proof of current Liability Insurance (must have a minimum of \$2,000,000 commercial general liability and \$2,000,000 commercial auto liability)
- c) Letter of Good Standing with the Manitoba Workers Compensation Board
- d) Timeframe of commencement and completion of the job

3. REJECTED BIDS

Bids that contain any of the following irregularities may be rejected by the discretion of the RM; unsigned, incomplete, conditional, arithmetic errors, additions not called for or alterations, and any bid which contains price adjustments or escalations for fuel. The Bidder agrees that the bid is open to acceptance and irrevocable for thirty (30) calendar days.

4. DELIVERY OF BID

Gravel haul tenders are to be submitted no later than **April 30, 2026 @ 4:00 PM.**

5. ACCEPTANCE OF TENDER AND COUNCIL APPROVAL

- a) A Certified Resolution of Council shall constitute acceptance of a bid.
- b) All submissions will be presented to Council for review, and Council will have final approval of any submission to be awarded.
- c) No action of the RM shall be deemed acceptance of a bid other than a written "Notice of Award."

6. AWARD OF TENDER

- a) Tenders will be opened and read publicly during the regular meeting of Council on *May 13, 2026.*
- b) The RM reserves the right to reject any or all tenders, and/or waive any minor non-compliance where, in the opinion of the RM, it does not result in an unfair advantage to any bidder.
- c) The lowest or any bid will not necessarily be accepted.
- d) The RM may, at any time and without liability, withdraw from negotiations with any or all proponents.

7. CONTRACT EXECUTION

- The successful bidder will be required to enter into an agreement with the RM of Alonsa.
- The successful bidder shall be required to sign the contract agreement within seven (7) working days after notice of award.

8. BUDGET AND SCOPE ADJUSTMENT

- The RM has a strictly defined budget for the work within this Tender and reserves the right to change the scope of the contract to bring the price within available budget limits.

9. PROPONENT COSTS

- The RM will not be liable for any costs incurred by proponents in the preparation or submission of responses to this Tender.

10. SAFETY REQUIREMENTS

- The Contractor shall maintain all equipment in good working order and shall perform all obligations expressed and implied in this Contract, in a good, safe, and workmanlike manner. All work shall be carried out in accordance with the safety requirements set forth in the latest version of the Occupational Health and Safety Act, including all PPE. The Contractor shall provide proof of Worker's Compensation coverage within seven (7) calendar days from the date of award of contract, and prior to commencement of said contract.

11. UTILITIES

- When required, it is the Contractor's responsibility to understand any implications for overhead utility lines or cables may represent and any additional cost due to any damage imposed on these utilities shall be borne entirely by the Contractor.
